This certifies _____, hereto referred to as Mare Owner/Agent, has engaged one service to the stallion _____, for the mare _____ Reg # _____ for the 20__ breeding season beginning February 1st, 20___. The mare owner agrees to pay a breeding fee of _____, which includes a \$500 non-refundable booking fee, any deviation from these terms must be specified in writing and signed by TNR. All payments must be made payable to TNR.

PRE-BREEDING ARRANGEMENTS: The mare owner must provide the following information when booking a mare:

1. Copy of both sides of registration certificate
2. Completed Information Sheet
3. Signed breeding contract
4. All applicable fees
 - A. The booking fee and breed fee must be paid in full before any cooled semen will be shipped
 - B. Any incomplete registration certification or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report
 - C. Semen will not be shipped to any mare unless a current credit card number and expiration date is on file. Shipping is prepaid with a check or money order payable to TNR

BREEDING ARRANGEMENTS:

1. Collection days are Monday/Wednesday/Friday. It is the mare owner's and his/her veterinarian's responsibility to confirm our breeding/shipping days.
2. To guarantee shipping, mare owner or agent, must give at least 24 hour notice of possible semen shipment and confirm shipment prior to actual shipment by 8 AM on day of collection.
3. Every effort will be made to accommodate your mare's breeding time frame; however, it is the mare owner's responsibility to keep in touch so that your veterinarian and ours can get your mare in foal in a timely manner. Failure to these arrangements may result in missed heats and delayed shipments, at the mare owners expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations in order to maximize the potential of a timely pregnancy.
4. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare may be bred without any additional breeding fee. No refunds given on any fees associated with this contract.

PAYMENT INFORMATION:

All payments may be made by check, credit card, or money order. A 3% processing fee applies to payments made with a credit card. All shipping and charge fees are subject to change. Payments must be made in full prior to semen shipped.
